The Punjab State E-Governance Society in the Department of Information Technology is an entity of the State and headed by Hon'ble IT Minister with Principal Secretary IT, Principal Secretary Finance, Chairman PSEB ,Secretary Local Govt, MD-Punjab Infotech, Director IT and 3 external IT experts as its members.

The main objectives and functions of the PSEGS are to promote efficiency, reduce delays, enhance accountability, transparency and objectivity in the functioning of the government., assist the Department of IT in formulating and implementing policies, procedures and guidelines for the adoption of Information Technology and to administer the implementation of E-Governance projects for ensuring use of Information Technology for masses.

The society has a large number of e-governance projects in hand which are at various stages of implementation. The projects are mainly under the National e-governance plan (NeGP) of Govt of India.

The Punjab State E-Governance Society in the Department of Information Technology, Punjab imparts Industrial / vocational training for BE/B-Tech (E&CE)/CS/IT and other technology students. This will give the youth of the region valuable training in the field of IT and help in promoting and building of a pool of Information and Communication Technology (ICT) skilled manpower, well versed in the use of ICT tools as well as to give impetus to the e-governance initiatives mentioned above in the State of Punjab .

The next Batch is started shortly starting from 1st Feb 2011 to June 2011.

The selection of the students will be done by a committee of technocrats based on academic performance and interview to be held on 20<sup>th</sup> and 21<sup>th</sup> Jan 2011 as per the following criterion

| 1.      | Marks/Grade in 1st Year             | 20             |
| 2.      | Marks/Grade in 2 <sup>nd</sup> Year | 30             |
| 3.      | Marks/Grade in 3 <sup>rd</sup> Year | 30             |
| 4.      | Interview                           | 20             |

The total marks will be 100. The marks with respect to criteria 1,2 and 3 above will be calculated on proportionate basis of the marks obtained by the student and in case of grade system the average marks of the range of corresponding to the particular grade will be taken for the calculation purpose.

PSEGS will pay the trainees a stipend of Rs 4000/- per month and they will work on various e-governance and other IT projects assigned to them for minimum of 40 hrs a week.

The next batch of Industrial Training of is to commence from 1st Feb 2011 to June 2011, therefore it is requested that eligible students in your college may be informed of this communication through appropriate means (in addition this communication should also be prominently displayed in your institution's notices board). Students will need to apply to PSEGS latest by 17<sup>th</sup> Jan 2011 by sending their CV's as per attached format to trainingdit@punjab.gov.in and copy to trainingdit@gmail.com. Kindly note that paper applications shall not be accepted and the students MUST send their details of marks as stipulated in the CV.
