This has reference to your two Applications No. 650 and 651 dated 20/12/2013 in Tier-I format seeking accreditation by National Board of Accreditation to PG Engineering programmes offered by **Gurunanak Dev Engineering College, Gill Park, Gill Road, Ludhiana, Punjab.**

2. An Expert Team conducted on-site evaluation of the programmes during **24<sup>th</sup> to 26<sup>th</sup> March, 2017**. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programmes as given in the table below:

4. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

5. The Programmes have been granted Provisional Accreditation. **Gurunanak Dev Engineering College, Gill Park, Gill Road, Ludhiana, Punjab** should submit the Compliance report at least 6 months before the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to **Gurunanak Dev Engineering College, Gill Park, Gill Road, Ludhiana, Punjab** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited level of programmes and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.


